











- Payment for the party is as follows. £50 non-refundable deposit to be paid upon booking of the party, the balance is due on arrival via bank transfer - please ensure you have a banking app on your phone.
 - All children **MUST** wear appropriate footwear (wellies/walking boots) to prevent slip, trips and falls and provide protection in the event of an animal stepping on a participant. We also advise that no jewellery be worn. That arms are covered to the elbows and no shorts or 3/4 length trousers are worn. Long hair must be tied back.
 - The party will take place even if the weather is poor. However, if the weather conditions are adverse and risk cannot be minimised, then a full refund will be given.
 - Children attending the Pony Party remain the responsibility of the organisers and/or guardians in attendance on the day. At no point must they be left on their own or in the care of Breathing Space staff.
 - The gates to the farm site will be unlocked 10 minutes before your scheduled party time. We ask for consideration when parking your vehicle and that car shares take place where possible to limit disruption for other farm residents.
 - We request that party participants remain within the designated party area - the farm is a shared site, we don't own it, therefore other horse owners may be onsite during your scheduled party.
 - Do not bring dogs on to the farm.
 - No smoking is allowed on-site.

 - Please ensure any children with allergies to animals take appropriate precautions prior to attending the party.
 - Although we provide adequate staffing to ensure the safety of our animals during our parties, we do not take responsibility for looking after children. Please ensure you provide adequate supervision and that you reinforce the information we provide during the safety briefing at the start of your party.
 - The participant(s) acknowledges that horse/animal based activities can be dangerous and that animals can act unpredictably. The participant(s) agree to follow all instructions given to reduce risk to everyone involved (human & animal). We, as an organisation, accept no liability for incidents, accidents or injuries sustained by anyone in attendance at your pony party.
 - Photos may be taken during the party for social media purposes - if you do not want your child to feature in these photos, please make a member of our staff team aware during the safety briefing.
